Back ground of the organization

Expertise France, a public agency placed under the authority of the Ministry for Europe and Foreign Affairs and Economic and Financial Ministries, is an actor in solidarity and influence. In the field, Expertise France supports, advises and assists partner countries in the design and implementation of sound public policies. The agency designs customized technical assistance projects and gathers the expertise required for their implementation.

In Liberia, Expertise France manages the TWIN2H – Twinning for Hygiene in Hospitals. The general objective is to contribute to the durable reconstruction of the health-care capacities of the national systems, particularly with regards to hospital hygiene and the safety of both patients and staff. The project aims to strengthen the capacities of 3 hospitals with regards to hygiene, which means to insure the rehabilitation and correct functioning of infrastructures (water, water management and disposal) on the 3 sites (Redemption Hospital and TB Annex in Monrovia, and Government Hospital in Buchanan)

Objective and expected results

1.1 Objective

To construct, complete specific section or needs of three partner hospitals and turn over these facilities in a fair condition. The rehabilitation of these hospitals in specific dimension is an extension for the intervention in two counties (Grand Bassa, and Montserrado County respectively).

1.2 Expected Results

At the end of these activities, the below listed will be achieved;

1. The construction of an open shed Out Patience Department (OPD) in the compound of TB annex, opposite the Ministry of Health.
2. Creating a maternity ER section and renovating the existing training room at the Redemption Referral Hospital
3. Rehabilitation of Antenatal Care unit, Morgue and the repair of damaged roof of the main building at the Buchanan government hospital.
