# **Project Description**

ActionAid Liberia is implementing a two-year Global Fund/PSI project titled: "HIV/AIDS Prevention, Care and Support for Key Populations, PLHIVs and the General Population with funding from Global Fund through Population Services International. The project seeks to reduce the prevalence of HIV/AIDS and provide care and support to those infected and affected by the pandemic. The project also works with local organizations (SAIL and LibNeP+) to build their capacity in the delivery of HIV/AIDS related services to their respective communities. As a way of enhancing its response to the needs and concerns of the target beneficiaries, the project intends understanding the barriers and challenges faced by key populations in accessing services, particularly health services. It will develop an annual report that details these barriers and challenges and develop a response plan to addressing these issues. A precursor study (Audience Insight Survey) was conducted in December of 2016 by ActionAid Liberia and its partners. This study generated themes based on identified barriers faced by the key populations in their respective communities that are to be used to develop behavior change messages on HIV/AIDS prevention, care and support.

- Initiate meetings with the Crisis Prevention and Management Incorporated in Committee established by ActionAid Liberia
