Interested Bidder can make payment for the bidding documents at the Roberts International Airport Procurement Section, Margibi County.

  - Annual average turnover of **US\$500,000** for each of the last **Three (3) Years** beginning **2014, 2015** and **2016** respectively;
  - Audited Financial Statement for the last three years beginning **2014, 2015** and **2016** respectively
  - Demonstrate ability to provide onsite after Sale service and Genuine Parts
