BACKGROUND

YOCEL is a Liberian non-profit organization that promotes quality education and provides a supportive platform challenging the creativity of young people. Consultancy Focus Background: Youth Coalition for Education in Liberia (YOCEL) with funding from Kids Rights International through the Ambassador Abraham Keita advocacy funding developed the Making Children Voices Count Project to amplify the voices of children and to ensure that stakeholders protect the rights of children. The project's model is to use done using ICT platforms, mainly the social and multimedia platforms.

❖ Position summary

He/She will serve as consultant to develop a comprehensive training manual that will comprise of all of the basis element of training manual development with primary focus on Children, using all of the National and Global instruments that promote and protect the welfare of children.

The hired consultant will provide technical support and identify relevant stakeholders both with INGO and Government instructions to look at synergy and best linkage on how to conduct the training. Specific instruments to consider will include but not limited to The Liberia Children Law of 2011, the UN convention on the rights of the Child and the African Charter on the Right and welfare of a Child. The training manual should have a linkage to the following organization in line with the kind of work they do: Ministry Of Gender Children and Social Protection, Plan – International, and Defense for Children

❖ Training Kites Key Focus Area

The development of the training kites should focus on the methodology approach that will be used through Advocacy and the development of messaging in areas such as domestic violence, Rape, Access to Education, Teenage Pregnancy, Street Selling, Corporate punishment and other issues that affect the welfare of a child.

❖ Task & Responsibilities

The hired consultant shall be require to deliver on the following

- Conduct a desk review of all of the existence Laws that promote and protect the rights of children with emphasis on the legal instruments listed above and other current or existence one.

- Conduct a context situational analysis on the current issues that affect the lives and wellbeing of children in Liberia
- Develop a model advocacy strategy and approach to carry out the advocacy
- Develop an effective communication strategy, using social and multimedia approach
- Develop a comprehensive Training Manual using all of the legal instruments both National and international
- Develop Advocacy messages in line with the training manual
- Develop an referral path way that will inform the advocacy approach in gathering the data and making analysis
- Develop and advocacy tool using social and multimedia approach
- Provide expert coaching to institutional staff on the implementation of the training manual
- Experience in conducting training with children and Youth advocate
- Provide sub topics to links the specific working of selected organization to develop their training material
