Scope of Work

The consultant will undertake the following tasks:

- Review national and international agriculture and livestock policies.
- Conduct individual/ group consultation meetings with Ministry of Agriculture, Research Institute and other relevant stakeholders for data collection and information validation.
- Conduct consultation with farmers through focus group discuss (FGD) to know the existing agriculture and livestock practices at local, regional and national levels.
- Give final review and edit the second draft which will be eventually made into the final version.
- Incorporate feedback from BRAC and revise the manuals accordingly.
