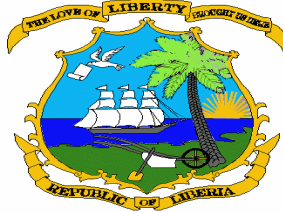


# Invitation for Bids

### Contract Title: Renovation Works for Social Registry Unit Supply and Installation of Infrastructures for a Data Center

The Republic of Liberia has received a loan financing from the World Bank toward the cost of the Liberia Social Safety Nets(LSSN) Project, and intends to apply part of the proceeds toward payments under the contract <sup>1</sup>for Renovation Works for Social Registry Unit for Supply and Installation of Infrastructures for a Data Center
  2. The Ministry of Gender, Children and Social Protection now invites sealed bids from eligible bidders for Renovation Works of the Social Registry Unit, **Supply and Installation of Infrastructures for a Data Center.**

Bidding will be conducted through the National Competitive Bidding (NCB) procedures as specified in the World Bank's *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers* January 2011 Revised July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
  4. Interested eligible bidders may obtain further information and inspect the bidding documents during office hours 10 am to 4pm at the address given below.
  5. A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **USD30.00** United States Dollars. The method of payment will be Cash. The document will be sent by email/or physical collection from the Ministry. The document will be issued from the Procurement Unit, Second floor at Ministry of Gender, Children and Social Protection office, Capitol Bye Pass.

Electronic bidding or submission **will not** be permitted and late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend at the address below on **June 6, 2018 at 11:00am**.
7. **All bids must be accompanied by a "Bid Security" of \$21,000.00 only from a reputable commercial bank and an insurance bid security shall not be accepted.**
