

UNICEF REQUEST FOR PROPOSAL – NATIONAL INSTITUTIONAL SERVICE REQUEST FOR HIRING A SERVICE PROVIDER TO PROCURE & INSTALL A 30KW SOLAR SYSTEM FOR ALTERNATIVE ENERGY FOR THE WALK-IN COLD ROOM AT THE NATIONAL VACCINE STORE LOCATED IN CONGO TOWN OPPOSITE THE NPHIL COMPOUND, LIBERIA

PURPOSE: UNICEF Liberia is seeking to contract a national institutional solar energy provider to install a 30KW solar system to support the electricity supply from the national grid to the walk-in cold room.

 - Tax Registration Certificate (most current)
 - Any other licenses or authorizations issued by the appropriate government authority to operate a business in Liberia
- e) At least five (5) references of major customers/clients
- f) Companies must not have prior record of inappropriate conduct in ethical, social or environmental issues (corporate responsibility)
- g) UNGM registration number (see direction provided in bid package)
- h) Signed copy of UNICEF PSEA form
