## REQUEST FOR EXPRESSION OF INTEREST (REOI) FOR (CONSULTANCY SERVICES-FIRM SELECTION)

**TITLE: CONSULTANCY SERVICES TO DEVELOP CYBERSECURITY FRAMEWORK,  
AWARENESS AND ORIENTATION**

The Telecommunications Act of 2007 established the Liberia Telecommunications Authority (LTA), to facilitate development of the telecommunications sector in order to promote social and economic development throughout Liberia; promote the efficient and reliable provision of telecommunications services, relying as much as possible on market forces such as competition and private sector investment to achieve this objective. LTA as a premier regulator, endeavors to promote economic growth in the Telecoms Sector, and at the same time provide protection for telecom consumers.

Against this backdrop, the Government of Liberia acting through the Liberia Telecommunications Authority (LTA) with financing facility from its approved budget for 2024 fiscal period now seeks to receive expression of interests from experienced and professional cybersecurity firms to develop cybersecurity framework, create awareness and orientate relevant staff about cybersecurity issues. Interested firms with relevant experience in cybersecurity are invited to submit an expression of interest (EOI) to the Liberia Telecommunications Authority (LTA). EOI received will be vetted and pre-qualified based on the responsiveness to the Request for Expression of Interest (REOI).

Firms endeavor to participate in this exercise shall have the relevant experience in cybersecurity issues or shall have handled similar assignment before. Henceforth, interested firms shall submit the following mandatory requirements along with a cover letter precisely indicating its interest in the assignment.

1. Company's profile
2. Provide evidence of extensive experience of firm with a minimum of 7 years in telecommunications concept, cybersecurity concept and /or multimedia content production
3. Valid Business Registration Certificate (Liberia Business Registry-LBR)
4. Valid Tax Clearance (Liberia Revenue Authority-LRA)
5. Vendor Business Registration Receipt (Public Procurement and Concessions Commission-PPCC)
6. A track record of successfully supervising or completing at least three (3) similar assignments

7. Submit updated CVs of two key staff members
