

EXECUTIVE ORDER NO. 102

EXTENSION OF EXECUTIVE ORDER # 97 THE SUSPENSION OF TARIFF ON AGRICULTURE PRODUCTS

WHEREAS, to solidify the gains realized under Executive Order No. 97 and to continue to accelerate the development of the forestry and agricultural sectors in Liberia;

WHEREAS, the Government of Liberia, pursuant to its "Pro-Poor" Agenda for Prosperity and Development (PAPD), seeks to promote a stable Macroeconomic environment that enables private-sector-led economic growth, greater competitiveness, and diversification of the economy;

WHEREAS, consistent with the PAPD, the Liberian Government and International Partners are making tremendous efforts to boost the Agriculture Sector by working with key market players to make agriculture affordable for farmers through; inter alia, farm development and management, aggregation, Good Agriculture Practices (GAP), Training and enabling Legislation that would boost Agriculture output;

WHEREAS, in keeping with this development initiative, the findings of Local and International Partners in the Agricultural Sector and its own internal review, it has reached the Government of Liberia that the Tariffs associated with Agriculture Inputs are high; thus, affecting the Agricultural Sector adversely and poor Rural Farmers who rely predominantly on Agriculture for their livelihood;

WHEREAS, the Government of Liberia realizes that the causal effect that such high Tariffs have on the Agricultural Sector and livelihood of Rural Farmers, contravenes its Agenda to promote a stable Macroeconomic environment, enable private-sector-led economic growth, competitiveness and diversification in the Liberian economy;

ENVISIONING that by lowering the Tariffs associated with the importation of Agricultural Inputs, the imports of agro-distributors would increase, and the price of Agriculture Inputs to Farmers would be lowered:

WHEREAS, it is further projected that by reducing the Tariffs on Agriculture inputs, Farmers would be able to access high quality agriculture inputs at affordable prices, agricultural productivity would improve, agricultural activities would become commercially viable; product consistency would increase; and Local Farmers would have sustained high incomes;

COGNIZANT that the effect of reduced Tariffs on the Agricultural Sector brings the Government of Liberia closer to achieving United Nations Sustainable Development Goal (#2) of ending hunger, improved nutrition, achieving food security, and promoting sustainable Agriculture;

AWARE that an Amendment to the Customs Tariff of Liberia of 2017 to affect Tariffs currently imposed on Agricultural inputs, would require a lengthy Legislative process that would not be best "CHANGE FOR HOPE" in the current public interests;



REALIZING that the temporary suspension of Tariffs on Agriculture Inputs would solve the aforementioned issues in the short term until such time that the Government of Liberia deems it necessary to enable Legislation in this regard;

COGNIZANT that in the exercise of the Executive Powers vested in the President by the Constitution of the Republic of Liberia, the President may issue an Executive Order in the public interest, either to meet emergencies or to correct particular situations which cannot await lengthy Legislative processes;

NOW THEREFORE, the Government of Liberia hereby Suspends Import Tariffs on the types of Agriculture Products and Equipment, directly related to Agriculture development and classifies under the Tariff Numbers of the Harmonized System and Customs Common External Tariff Schedule of 2017 of the Republic of Liberia, as attached to and forming a cogent part of this Executive Order.

ACCORDINGLY.

- 1. The Minister of Finance and Development Planning, in consultation with the Minister of Agriculture and Commissioner General of the Liberia Revenue Authority, shall establish the processes and procedures by Administrative Regulation for the granting of Tax Exemption to eligible Beneficiaries within the Agriculture Sector.
- 2. Importers of Agriculture Inputs shall pay only Customs Users Fees (CUF) and the ECOWAS Trade Levy (ETL) where applicable;
- 3. That Beneficiaries of this Executive Order must be directly involved in the Agriculture Sector, as verified by the Ministry of Agriculture; and
- 4. This Executive Order shall take immediate effect.
