Role Summary

The Chief Executive Officer (CEO) serves as the primary strategic and external-facing leader of LEAD Monrovia Football Academy (LEAD MFA). The CEO will be responsible for advancing the organization's mission to develop ethical, empathetic, and entrepreneurial leaders through high-quality education and sport. Working closely with the Board of Directors and in alignment with LEAD Edu's network-wide initiatives, the Executive Director will shape LEAD MFA's strategic vision, promote innovation and scaling of impact, build external relationships, secure sustainable funding, and provide high-level oversight of operations and programs to ensure organizational excellence.

LEAD Monrovia Football Academy (LEAD MFA) is an independent, nonprofit organization based in Liberia that provides Liberia's talented youth with full-time academic classes, football training, and life skills lessons to improve academic performance, break down gender barriers, and prepare our students to lead positive change in Liberia.
