The Government of Liberia has received financing from the African Development Bank Group (AfDB) hereinafter called the Bank toward the cost of the Mano River Union Road Development and Transport Facilitation Programme (MRU/RDTFP) Phase I: Paving of Karloken to Fishtown (80km), and intends to apply part of the proceeds toward payments under the contract for the renovation of the Public Financial Management Unit (PFMU) Office at the Ministry of Finance & Development Planning (MFDP). “For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank’s Disbursement Guidelines and procedures for Investment Project Financing.”

The Ministry of Public Works now invites sealed Bids from eligible Bidders for the renovation of the Public Financial Management Unit (PFMU) Office at the Ministry of Finance & Development Planning (MFDP) the renovation of the Public Financial Management Unit (PFMU) Office for a period of six (6) weeks at the Ministry of Finance & Development Planning (MFDP).

Bidding will be conducted through the Open Competitive Bidding (National), (ONCB) method as specified in the Bank’s Procurement Framework “Procurement Policy and Methodology for Bank Group Funded Operations” (BPM), dated October 2015”, and is open to all eligible bidders as defined in the Procurement Framework.

The document will be shared hard and soft copy with potential bidders that apply for the bidding document and sent by email to those potential bidders that may request the bidding documents.

Bids must be delivered to the address below on or before **11: 30 am, May 15,2025 at the PIU Office MPW**. Electronic Bidding will not be permitted. Late Bids will be rejected and return as submitted. Bids will be publicly opened in the presence of the Bidders’ designated representatives and anyone who chooses to attend at the address. All Bids must be accompanied by a “Bid-Securing Declaration.

Attention is drawn to the Procurement Framework requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document."
